

**PORT WORKS APPLICATION
COMMERCIAL AND RECREATIONAL DIVING**

THIS IS AN APPLICATION TO OBTAIN PERMISSION FROM THE PORT OF PORTLAND TO CONDUCT WORKS/DIVES AND DOES NOT REMOVE THE REQUIREMENT FOR PORT USERS TO COMPLETE THEIR OWN SAFE SYSTEMS OF WORK, INCLUDING PERMITS WHERE REQUIRED.

Approval must be obtained for all diving and in-water operations within port waters. Applications are required for any commercial work carried out below the surface of the water either by a professional dive company, POPL divers or the contractor's own divers. Applications must be applied for during business hours. **This application must be lodged a minimum of 24 hours prior to commencement of dive request.**
