

## PORT WORKS APPLICATION CRANE / HEAVY LOAD

THIS IS AN APPLICATION TO OBTAIN PERMISSION FROM THE PORT OF PORTLAND TO CONDUCT WORKS AND DOES NOT REMOVE THE REQUIREMENT FOR PORT USERS TO COMPLETE THEIR OWN SAFE SYSTEMS OF WORK, INCLUDING PERMITS WHERE REQUIRED.

An Application must be obtained for all crane operations where maximum outrigger, track or wheel loads exceed legal highway loads, for all works close to power lines, when using man cages, when exceeding 85% of the rated maximum loads, for works over occupied buildings, for works from berths or jetties and adjacent to a sheet piling edge and multiple crane lifts.
